The \$20,000 sponsorship will be distributed to all foals placing in the Spectacular with an additional \$2,500 awarded to the sire owner of the champion filly foal and the champion stud foal. The 2019 Clydesdale Foal Spectacular will be held in conjunction with the 2019 Michigan Great Lakes International Draft Horse Show (October 17-20, 2019).

Hurry! Mare & Stallion Nominations are **due January 1, 2019!**

The Spectacular is a form of recognition that allows breeders to look into the future and take a chance on their efforts as breeders. It is a conscientious attempt to ensure future excellence in the breed by rewarding breeders on the success of their program.

Premiums will be comprised of:

- 1) Monies from nominated dams and sires
- 2) Monies from nominated foals
- 3) Monies from donations and sponsorship

Purses for foals placing first through tenth will be paid a percentage of the nomination fees, additional sponsorships and related fees. The schedule may be adjusted based on sponsorships. The premiums will be split between filly and colt classes. Classes may be split based on foal age if number of entries warrants it on the discretion of the Spectacular committee.

1st – 28%
2nd – 23%
3rd – 17%
4th – 12%
5th – 10%
6th – 10%
7th-10th - \$200

Foals nominated and exhibited in the Spectacular classes must be entered in the open classes. Foals must be registered to compete in the 2019 Spectacular.

The first step is nomination of your bred mare and stallion. The deadline for stallion and mare nomination is JANUARY 1, 2019 as determined by postage mark with no exception. The stallion nomination fee can be paid by the stallion owner or the mare owner if the stallion owner chooses not to.

BRED MARE NOMINATION FEE IS \$50.00
STALLION NOMINATION FEE IS \$50.00

The second step occurs September 1, 2019. You will submit the registered name, sex and date of birth, and registration number with \$50.00 nomination fee by September 1, 2019.

FOAL NOMINATION FEE IS \$50.00

No refunds of nomination or related fees with no exceptions.

A service charge of \$25 will be required for returned checks. Failure to pay this service charge and honor the check within 30 days of notification will result in disqualification without recourse of the nominations or related fees covered by that check.
